## **2024 Summer Community Supported Agriculture (CSA) Program**

We are delighted to offer our CSA again & welcome you to join us in this wonderful venture!

#### How our program works...

You purchase a seasonal share in our farm (full or half) and we pick the freshest, highest quality produce, free range eggs, make delicious canned goods, & raise all natural, USDA pork & chicken for you and your family on a weekly basis. All of our non-GMO products are fresh picked for you that day (canned items are made fresh from only the produce grown on our farm, pork & chicken is raised all naturally with lots of love & care, and eggs are pulled from the coop that day). We use Integrated Pest Management (IPM), low spray or no spray whenever possible. We will include 1 dozen of our free-range eggs and 1 jar of our canned goods per month. For the pork & chicken, you will be given the option to ask for a \$10.00 gift certificate that can be used to purchase our all natural, USDA pork/chicken at our farm stand (so you can pick exactly what cut of meat you'd prefer) or, you don't have to choose this option & continue with your regular weekly selection of produce. If you choose the pork/chicken option, \$10.00 worth of product will be removed from your bag that week. All items included in the bags will be a sampling of what we're harvesting that day! Please note that our CSA does not allow for any substitutions. If you have a dietary restriction, please let us know & we'll work with you on that. Thank you.

Your choice of a pick-up day will be Sunday thru Thursday from 2:00pm to 6:30pm at our farm stand at 1098 Main Street. Our CSA will begin on Sunday, June 16<sup>th</sup> and run through Thursday, October 31<sup>st</sup>. We are only offering 20 CSA memberships/day, so please submit your application quickly to ensure you are a part of this exciting offer as spots are reserved on a first come, first served basis.

#### How much does it cost?

A full share for the 2024 season costs \$800 which entitles you to a full bag of product every week for the 20 week season (which consists of no less than \$40 worth of product per week) or, if you don't need that much product, you can purchase a half share for \$450 which entitles you to half a bag every week for the 20 week season (which consists of no less than \$22.50 worth of product per week).

#### How do I become a member?

Complete & send in the CSA Application with payment.

#### What are the benefits?

As a member, you will receive a share of Killam & Bassette Farmstead's quality products. Our produce is picked fresh the day you receive your share, our free range eggs are pulled from the coop that day, and our award winning canned goods are made fresh only from the produce on our farm! You will also be given the opportunity to receive a \$10.00 gift certificate (in lieu of \$10.00 worth of product on a specific week) for our all natural, USDA pork/chicken that can be purchased at our farm stand right when you pickup or save for another time. Everything is as fresh as if you picked it yourself and delivers the most nutrients to you, our customer. You can taste the difference! As always, "Keep it Local, Keep it Fresh"!

#### What are the risks?

We are committed to provide you with the highest quality products but there are risks in agriculture (Mother Nature's whims, disease, pests, etc) that need to be shared by the whole community. Your payment entitles you to a share of the produce we harvest during the relevant growing season.
